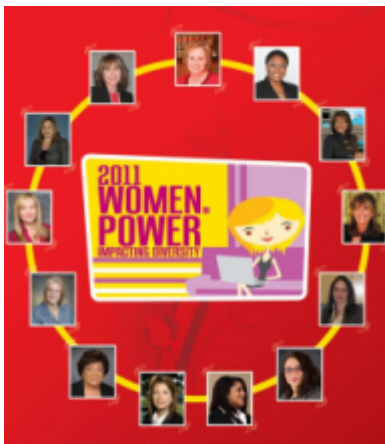
robust commitment to increasing the reach of the NGLCC supplier diversity initiative. The event took place at the National Building Museum in Washington, DC.
